Program Description: Idaho Legal Aid Services, Inc. (ILAS) is a statewide nonprofit law firm that serves the civil legal needs of low-income and vulnerable Idahoans. Our clients include: survivors of domestic and sexual violence and stalking; housing insecure Idahoans; vulnerable seniors and children; farmworkers and Native Americans.

This position would work with the Migrant Farmworker Law Unit in matters of civil legal representation in federal and state courts and before administrative agencies. The most common legal issues faced by agricultural workers in Southern Idaho include matters related to wage theft, workplace health and safety, housing, civil rights abuses, public benefits, consumer law, immigration, labor trafficking and other issues.

The Migrant Farmworker Law Unit Staff Attorney's duties will include providing legal services, including but not limited to: managing cases and casework; calling and meeting with clients; interviewing witnesses; trial preparation; researching and writing briefs and memorandums; drafting complaints and other pleadings; and litigating matters. The attorney will be expected to use professional judgment to manage a caseload. This attorney will draft written legal education materials in English and Spanish and conduct outreach and education to farmworkers and individuals and organizations that serve the farmworker community

Location Descriptions:

Nampa: Nampa is a midsize city in the Treasure Valley region, located just twenty minutes west from the capital city of Boise, and is the third-largest city in Idaho. Nampa is located in the heart of the Snake River Valley AVA, one of the fastest-growing wine regions in the U.S., and is near to over twenty local wineries. The Ford Idaho Center is also located in Nampa which is the largest amphitheater in the Treasure Valley and hosts events such as major concerts, sporting events, trade shows, and the Snake River Stampede Rodeo.

Twin Falls: Twin Falls is a small city in southern Idaho, known as the gateway to the Snake River Canyon and the center of the Magic Valley. Nearby Sawtooth Mountains provide abundant world-class recreational opportunities, including rock climbing, golfing, skiing, mountaineering, whitewater rafting, kayaking, cycling, and hiking. The applicant must have an interest in working with farmworkers in Southern Idaho and a passion for serving vulnerable and at-risk populations. The applicant must have a valid driver's license and access to an operational and insured vehicle that they are willing to use in the performance of their duties for this position. The applicant must be able to pass a background and driver's record check.

Benefits: This is a full-time position of 37.5 hours per week. The attorney would be eligible to participate in a limited telecommuting program after three months of working at ILAS.
